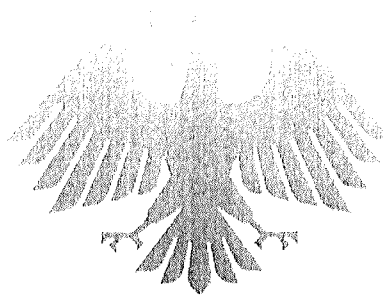

External/ Internal Fast-Track Tender Announcement

The Public Establishment of road Communication announces its intention to conduct an External/Internal Fast-Track Tender for the Rehabilitation and construction of a second branch for the road section extending from the Al-Busayri junction to the Al-Tanf crossing (170 km), plus a 45 km link from the Al-Sabaa Biyar junction towards Al-Busayri.

Contract duration: 900 calendar days

The tender is conducted in accordance with the Unified Public Entities Contracts System issued by Law No. 51 of 2004 and the General Terms and Conditions issued by Decree No. 450 of 2004, and in accordance with the Particular technical specifications and the special legal and financial terms and conditions.

The bidder is considered to have reviewed the project file according to the following conditions:

–Bid Bond: \$2,000,000 (two million US dollars only), Valid until the bidder's commitment to their offer expires, as mentioned in the legal and financial terms and conditions.

–Performance bond: 10% of the Contract Award Value.

All partners submit temporary and final guarantees in accordance with the legal and financial terms and conditions, and the application for participation includes that they are jointly and severally liable.

A receipt for the project file purchase must be submitted.

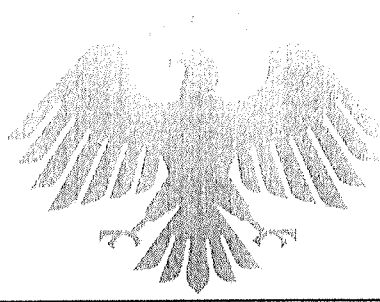
– The Bidder's commitment period to their offer: (60) sixty calendar days starting from the day following the deadline for submitting offers

–Commitment Period of the Successful Bidder: 180 days from the day following the date

The contractor is entitled to request an advance not exceeding /10%/ of the contract value, in accordance with what is stated in the legal and financial terms and conditions.

–Foreign bidders or companies must submit all required documents, duly certified by the relevant Syrian embassy or the Syrian Ministry of Foreign Affairs and translated into Arabic by a certified translator in Syria.

Bids must be submitted in three sealed envelopes, which are then placed in a fourth envelope addressed to the Public Establishment of road Communication. This fourth envelope must clearly state the subject of the tender, the date of the tender, the bidder's name, their chosen address in the Syrian Arab Republic, and their telephone number.

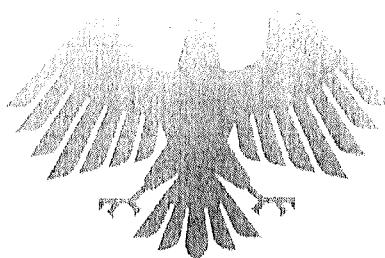
–It shall be sent to the office of the Public Establishment of road Communication in Damascus or sent by registered mail, provided that it arrives and is registered at the office of the Establishment in Damascus on Al-Hamra Street opposite the Parliament, in accordance with what is stated in the legal and financial terms and conditions book in both cases before the end of official working hours on the day *Tuesday* of 1/9/2026 AD

The bids will be opened in a closed session at exactly 10:00 AM on the day *Wednesday* of 2 / 9 /2026 AD.

Bids shall be submitted in US Dollars (USD).

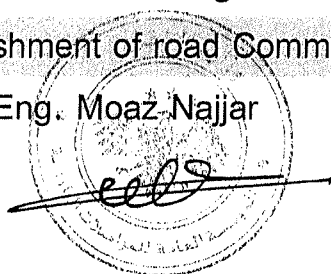
